Action: Moved to engage with Herd Feed Hartz to conduct a search for a permanent Superintendent with a fee based on per cent of the Superintendent's first year compensation by Commissioner Michnich; second by Commissioner Boteler. Motion passed, 5-0.

Bob T. commented about mentioning fiscal responsibility.


